"STEGGLES WOOLWORTHS" PROMOTION 2024

TERMS AND CONDITIONS

- 1. Information on how to enter and the prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian residents who are individuals and are aged 18 years or over.
- 3. Employees (and their immediate families) of the Promoter, Woolworths Group Limited and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, stepsister or cousin.

- 5. A "**Participating Store**" is any Woolworths store nationally that advertises the promotion in store or locally through social media, and stocks the Eligible Product (defined below) during the Promotional Period.
- 6. To be eligible to enter, individuals must purchase any Steggles product from a Participating Store during the Promotional Period ("**Eligible Product**") and obtain a purchase receipt ("**Qualifying Transaction**"). Subject to clause 8, individuals will only receive one (1) entry in the relevant Weekly Draw if they purchase one (1) Eligible Product in a Qualifying Transaction and will receive five (5) entries in the relevant Weekly Draw if they purchase two (2) or more Eligible Products in a single Qualifying Transaction.
- 7. To enter, individuals must then visit https://www.steggles.com.au/competition, follow the prompts to the promotion entry page, input the requested details, select the number of Eligible Products purchased in the Qualifying Transaction, upload their purchase receipt and submit the fully completed entry form during the Promotional Period.
- 8. Multiple entries are permitted during the Promotional Period, subject to the following: (a) only one (1) entry permitted in the relevant Weekly Draw if only one (1) Eligible Product is purchased in a Qualifying Transaction; (b) only five (5) entries will be permitted in the relevant Weekly Draw for the purchase of two (2) or more Eligible Products in a single Qualifying Transaction; (c) a Qualifying Transaction which has been the subject of an entry in a Weekly Draw cannot be used to submit an entry in any other Weekly Draw; and (d) each entry must be submitted separately and in accordance with entry requirements.
